# DESCRIPTION OF RESEARCH INTERESTS AND TRAJECTORY

My long-standing academic research focuses on how language use and its social distribution impact language variation and change, predominantly with respect to sound patterns. In general, I have focused most of my attention on Colombian varieties of Spanish, but have explored other languages as well, such as Brazilian Portuguese, U.S. English, and the sociohistorical foundations of Palenquero. I adopt a usage-based approach in which contextualization and frequency of use are at the forefront. The main idea is that regularly-occurring chunks of speech tend to be represented holistically in the mindbody, resulting in that the reference to its

individual compositional parts is eroded through the automation of neuromotor activities and higher predictability. In our recent work (Bybee et. al. 2016), we report on a study of the Spanish discourse marker, *o sea*, which may be loosely translated as 'that is, like, you know, it's that'. Our study looks at the spoken Spanish of Cali, Colombia, and finds that the discourse marker, *o sea*, has become much more compacted than the *sea*-'be'-subjunctive phrase from which it originated. Not only is the *o sea* shorter in duration overall (195ms vs. 256ms), the individual articulatory gestures that comprise it are more abbreviated (e.g. weaker /s/ and the /ea/ become more like a single vowel). The discourse marker *o sea*, outnumbers the subjunctive *que sea* by a ratio of 28:1 in our oral corpus. We conclude that the unique pragmatic function of the discourse marker, as well as its much higher frequency of use, are the primary factors that have led to its unique phonological shape.

In addition to looking at the effects of usage, the above study highlights several other trends that characterize my current research. I have argued in favor of using acoustic measurements in order to capture the subtle but relevant differences in sound variation. For example, our recent study (File-Muriel et. al. 2021) represents a first attempt to disambiguate between variation that is socially-learned behavior, such as that based on cultural conceptualizations of normative (male/female) gender constructions, from that which is attributable to individual physiological differences. While it is true that binary gender classifications tend to exhibit differences insofar as socially-learned sound variation, few studies have explored the role of individual physiological configurations. This is important because the physiological differences between speakers, such as oral and laryngeal tract configurations, *are* significant factors in predicting acoustic realizations of the sibilant sound <s>. Much of this variation has been attributed to gender constructs, highlighting the importance to control for physiological differences when carrying out sociolinguistic research.

My current work continues along lines exploring language variation and is evidenced by several recent co-authored studies that use the sociolinguistic interviews that I collected in Cali and Barranquilla, Colombia (2004-2009). We published an article in *Corpus Linguistics and Linguistic Theory* that addresses the lexically specific accumulation in memory of word and segment speech rates. We published a chapter looking at the role of bigram frequency in the realization of <s> across word boundaries in the Spanish of Barranquilla. Additionally, this year (2022), we published a paper in the *Journal of Phonetics* that critically examines the validity of acoustic measurements in the perception of <s> according to its embedment in different phonetic contexts. I published a book chapter this year in the Handbook of Usage Based Approaches to Linguistics (ed. Diaz-Campos) titled "Phonetics, phonology and usage-based approaches." I have another accepted for publication this year (2024), titled "La variación fonológica del español colombiano" (phonological variation in Colombian Spanish).

My recent research and teaching centers around a study abroad program/delegation that we collectively organize through international and intercultural partnerships. The program consists of a faculty-led delegation to Colombia, which focuses on cultural and linguistic sovereignty, the anthropology of knowledge construction, sustainability, interculturality, solidarity, and grassroots peace construction. We work closely with *Universidad del Cauca* and la Universidad *Autónoma Indígena e Intercultural* and participants gain insights into the language fortification practices (*Nasa Yuwe*) of the Nasa people. We have completed a draft, which is a dialogic discussion about our processes and plan to publish it in appropriate venues following the next delegation, which is planned for 2025. Related to this area of inquiry, I published a book review this year on Jean E. Jackson's 2019 book *Managing Multiculturalism: Indigeneity and the Struggle for Rights in Colombia*, which appeared in the *Journal of Anthropological Research* (University of Chicago Press).

#### DESCRIPTION OF TEACHING INTERESTS AND TRAJECTORY

I teach courses that attract students from a wide-variety of majors, including Spanish & Portuguese, Latin American Studies, Linguistics, Chicanx Studies, Political Science, Anthropology, Biology, Psychology, Sociology, among others. At both graduate and undergraduate levels, I have taught *Sound Patterns of Spanish*, for which I was awarded a Teaching Allocations Grant in Spring 2019 to further enhance the course and develop several student research initiatives. I teach a course on *Language and biodiversity*, which explores the relationship between language, cultural diversity and the role of the macrolevel sociopolitical processes that influence both. I teach a course titled *Language and Ideology*, where we examine topics such as language and thought, linguistic relativity, linguistic differentiation and discrimination, the emergence of language according to its surroundings and community needs, struggles to defend cultural autonomy, and the global processes, institutional and state interventions that influence language and culture. I also developed a course titled *Language Peace Transformation*, which examines in depth several alternative cosmovisions to western thought on language and its

purpose. All of these courses have been quite successful and have received very positive evaluations from the students. Perhaps my biggest pedagogically-related project was the co-creation of the quadrennial *Study Abroad Colombia* program, which entails taking a small group of students to the Cauca region of Colombia to learn about language and culture fortification practices and the political processes that support them. Participants in the delegation attend talks at local Universities, including the *Universidad Autónoma Indígena e Intercultural* and *Universidad del Cauca*, they participate in community visits, and they learn about the socio-political factors that influence language, education and cultural autonomy. I co-direct and co-teach courses related to the delegation, including *Peace Perspectives in Colombia* and *Study Abroad Colombia: Interculturality and Peace in the Andes*. Both of these classes are intended to prepare students for their experience abroad. Finally, due to the global pandemic involving the coronavirus (2020-2023), it was suggested that I teach a course on Integrative Health, which focuses on multicultural practices known to improve health and wellbeing.

In all of the courses that I teach, I strive to personalize them as much as possible, by offering students a variety of different options. For example, in my undergraduate *Sound Patterns of Spanish* classes, students carry out community-based fieldwork in which they interview a relative or friend that self-identifies as a native speaker of Spanish. The students personalize the interview by preparing questions that relate to their own interests and/or family history and work with this audio recording throughout the semester. This approach has worked well in terms of the fortification of Spanish here in New Mexico, because students use the Spanish language off campus in a novel situation, that is, for a sociolinguistic interview. At the graduate level, I open each semester with an open discussion of my suggested course readings and encourage the students to suggest further topics and readings based on their own interests. This usually results in a week or two of materials chosen by the students in dialogue with me. I strongly encourage students to develop course projects into publications. To date, five MA students under my direction have published their research in peer-reviewed venues.

#### **DESCRIPTION OF SERVICE COMMITMENTS**

I actively engage in service at the (inter)national, university and departmental levels. In addition to serving as abstract reviewer for a host of conference venues, I have served as a reviewer for a variety of high-impact journals in fields relevant to my areas of knowledge, such as the *Journal of the International Phonetic Association*, the *Journal of the Acoustic Society of America, Corpus Linguistics and Linguistic Theory, the Journal of Phonetics, Language Variation and Change, the Journal of Anthropological Research, and the Journal of Cognitive Linguistics*. I have also served as grant reviewer for the *National Science Foundation*.

Insofar as my service to the university, I served as chair and co chair of the *Health and Safety Advisory Committee* (HSAC) during the 2018-20 Academic Years and have remained on the committee as an active member until October of last year due to my sabbatical; the HSAC meets regularly with the Provost and advises them on issues related to international student travel and study abroad programs. I was elected and served a two-year term on the *Executive Committee of the Latin American and Iberian Institute*. I presently serve on the *Interdisciplinary Committee on Latin American Studies* (ICLAS), which creates new degree programs and classes as needed, makes curriculum and requirement changes to the Latin American Studies program, updates the comprehensive examination process, sets guidelines for admission of students to the program, reviews student application files, selects Graduate Assistantship and other financial aid awards, among other duties. In the past, I have also served on the Latin American and Iberian Institute's *Grants Allocation Committee*. I have actively participated in multiple Graduate Student Funding Initiatives and founded and organized the *LAII Interdisciplinary Talk Series in Linguistics*, which remains active to the present.

In terms of the departmental service that prepares me for administrative positions such as Department Chair, I have served as the *Director of Graduate Studies* for the Department of Spanish & Portuguese and have co chaired the *Undergraduate Committee*. I have served as the *Hispanic Linguistics Section Coordinator* on multiple occasions, most recently during Academic Year 2022-23. In all of these roles, I work to foster an environment in which different sections maintain cohesive relationships within our multidisciplinary department, which is characterized by different areas of cultural studies, including literary and oral traditions from multiple regions, creative writing, Portuguese, languages and Linguistics, Spanish as a Heritage Language (SHL) and as a Second Language (SSL), among others. I have served on five search committee for tenure-(track) hires since arriving at UNM in 2010 and have chaired the *Merit and Evaluation Committee* and served on the *Graduation/Activities Committee*. Additionally, I have certifications in conflict mediation (through the University's Ombuds program), Mindfulness Based Stress Reduction (University of New Mexico's Continuing Education program), and am a certified Yoga instructor (500 RYT) with extensive training in meditation, mindfulness, deep listening and

compassionate speech. This background has enabled me to recognize complex energies as they emerge and work collectively to transform them in a more harmonious direction.
